NOTICE IS FURTHER GIVEN THAT at such meeting the Board of the District intend to make a final determination concerning the issuance and incurrence of general obligation indebtedness consisting of a Capital Pledge Agreement, and including any necessary amendments or supplements thereto related to the issuance of such Series 2025 Bonds as described below, pursuant to which the District will be obligated to impose ad valorem property taxes for the repayment of obligations issued by Aurora Crossroads Metropolitan District No. 2, City of Aurora, Arapahoe County, Colorado, including its General Obligation Limited Tax Bonds, Series 2025A-3, in the estimated principal amount of \$10,000,000 (the “Series 2025 Bonds”), which amount is subject to increase or decrease as determined by the Board, or as otherwise permitted by any resolution adopted by the Board at such meeting in connection therewith, the Board will consider a resolution: authorizing the Capital Pledge Agreement; authorizing the issuance of such indebtedness; approving, ratifying and confirming the execution of certain documents; making determinations and findings as to other matters related to such financing transaction; authorizing incidental action; and repealing prior inconsistent actions.

NOTICE IS FURTHER GIVEN THAT pursuant to the Supplemental Public Securities Act, no legal or equitable action brought with respect to any legislative acts or proceedings in connection with the authorization or issuance of such bonds may be commenced more than thirty days after the authorization of such bonds pursuant to the aforementioned resolution.

The Boards will also take up such other business as may come before the Boards. The meeting is open to the public.

Pursuant to the provisions of the Supplemental Public Securities Act, one or more members of the Boards may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device. There will be at least one person present at the physical location posted on this notice.

This notice is given by order of the Boards of the District, and shall be posted on the District’s website, not less than 24 hours prior to the meeting.
